Dance 4 Life Tuition Requirements, Policies, and Waivers

- 1. Tuition is divided equally over 12 months regardless of the number of actual weeks in the month. If you are starting in the middle of a month, we will prorate your tuition for that month. We are a year round school, classes do not stop for the summer.
- 2. A non-refundable registration fee of \$50.00 (\$25 for each sibling), is due upon enrollment. The registration fee is NOT an annual fee. This fee will not be billed again unless a family drops for any length of time and then re-registers at Dance4Life.
- 3. Tuition is due and payable on the **FIRST OF EACH MONTH**. We gladly accept: Cash, Credit Card, Bank Draft, or Check payments- made out to Dance4Life. There will be a processing fee added to credit card payments and a processing fee added to bank draft payments.
- 5. <u>LATE FEES</u> are \$15.00 after the 10th, then an additional \$10.00 if not paid in full by the end of the month. You may be removed from the schedule if tuition is more than one month overdue. A repeat registration fee may also be required to return to classes. Dance4Life reserves the right to discontinue your lessons if tuition is not up to date.
- 6. There will be a \$35.00 charge for any returned check.
- 7. Any account that becomes 3 months past due will be submitted to a Collection Agency and will incur a 50% increase to your account to cover collection costs.

8. NO ADJUSTMENTS WILL BE MADE FOR CLASSES MISSED DURING THE MONTH.

- If the teacher cancels a class for any reason, a make-up class will be scheduled, or the student can join in a different class of your choosing during that month.
- Any classes missed due to illness or vacations by the student may be made up if notice was given <u>BEFORE THE CLASS WAS MISSED</u>.
- Dance classes may be made up by attending any other equivalent level class during the week.

- Unexcused absences, i.e. forgetfulness, bad weather, or lack of planning will not be made up.
- Studio closures due to hurricanes will not be credited, though we will do our best to provide make-ups. No credit will be offered for student cancellations.
- Notice to drop must be confirmed through email by the 15th of the prior month.
- You will continue to be enrolled through the end of the following month if notice is given after the 15th.
- Lack of attendance does not constitute a drop notice. You will be billed for any month during which you are enrolled. Emailed: dance4life.dance@gmail.com.

All of this information is also in the parent portal. Upon registration, you agree to the Tuition requirements and Policies (stated above) of Dance4Life. By participating in classes or performances, you hereby give permission for Dance 4 Life, its employees and/or assigned to administer medical treatment as they deem fit in the event of injury or other medical emergency involving the student. You understand that medical treatment could entail hospitalization, administration of first aid or any other treatment deemed necessary by Dance 4 Life, its employees or assigned. Although the studio will make every effort to contact you and/or the emergency contact prior to administration of medical treatment, You understand that this is not always possible or practical.

Dance4Life is not held liable for any injuries and you are dancing at your own risk.
